We are pleased to announce that our proposed 2018-2019 school district budget is maximizing school district tax dollars for the benefit of our students. Here are a few examples of your tax dollars at work in our schools:

- ♦ 96% graduation for June 2017 graduates
- 25 students received 32 awards from the CNY Scholastic Arts Awards
- ★ Two teachers were recognized at the state level for award-winning teaching practices



Also included are student services such as health, guidance, library, co-curricular, athletics, transportation, legal, census and the employee benefits for those programs.

Administrative Component

As defined by NYS Education Department, this budget category includes monies for the majority of the instruction support services in the District. It is comprised of a general support section, an instructional supervision section and a section for employee benefits for personnel in associated areas. This component represents 8.13% of the components. The categories marked with * and ** represent 78% and 65%, respectively, of the amount needed to operate these services; the balance is charged to the State for administering and maintaining financial records for the Onondaga Nation School.

Proposition I - Budget


Shall the Board of Education of LaFayette Central School District of the towns of Fabius, LaFayette, Onondaga, and Tully of Onondaga County, New York, be authorized to make the expenditures of the monies set forth in the proposed budget for an amount of \$18,964,918 submitted to the Annual Meeting on May 15, 2018 and levy the necessary tax therefore?

Proposition II - School Vehicles

Shall the Board of Education be authorized to purchase two (2) student transportation vehicles, and one (1) maintenance vehicle, including related furnishings and equipment incidental thereto, expend therefore a total sum not to exceed \$275,000 which is estimated to be the total maximum cost thereof, and pay for such buses by the levy of a tax which is hereby voted and approved in the amount of \$275,000 which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$275,000, and a tax is hereby voted to pay the interest on said obligations when due.
