- V. <u>Oral Communications</u>: Community Connections: Nicole Rookey, Prevention Network, a Teen Institute Representative, spoke about the program and that LaFayette High School has been a part of the program for close to 20 years. The program trains and empowers youth to choose healthy lifestyles. It teaches students to give back to their peers in a positive way. There is an annual conference and LaFayette did not have a team attend last year. Zachary Anthony, Senior, was involved in Teen Institute since 9th grade. He was disappointed that there wasn't a team from LaFayette this year. He felt he didn't have the support from the administration. He would like the program reinstated next school year. Feels it is important to students.
- VII. Old Business Grimshaw Elementary Principal Greg Bump presented information regarding PBIS (Positive Behavioral Interventions & Supports). PBIS's goal is to improve school culture and increase positive behaviors. How do we increase behaviors we want and how do we decrease behaviors we don't want? A training is scheduled for Friday, June 27, 2014 at the Jr./Sr. High School for employees. It is to help create a systemic, school-wide approach. A design team will meet following the training and will update the Board on the developments.
- VIII. New Business Superintendent Tigh reported on the Onondaga Nation School 4th grade teacher modules from the Common Core based on the Haudensaunee. When the staff looked over the modules, they found a lot of inaccuracies. They have been working with SED to rectify this problem. Today, a videographer went to the school to create an accurate module. Superintendent Tigh wanted to thank: the Onondaga Nation Leadership, Principal Ellsworth, Director of Curriculum and Instruction Cowling, and the staff and students at the Onondaga Nation School for their participation and patience.
