6) New Business

A. Building Conditions Survey was presented by Director of Facilities Kesler. He said the New York State Education Department requires school districts to have a buildings condition survey done every five years. It is so SED can get an overall idea of district buildings, athletic fields, and sidewalks. The survey determines priorities and it also give us life expectancy of our facilities. Mr. Kesler recommends Ashley McGraw Architects as they have performed the surveys in the past.

7) Superintendent Report

- A. Superintendent Updates Board
 - Superintendent Lavine again congratulated Coach Kelly on his achievement of 150 victories.
 She also extended her compliments to Chase LaCava for his Student Athlete award.
 - Ms. Lavine gave her praises to SBO Turner for her great work on the community budget meetings. A lot of good information was shared.
 - The Onondaga Nation School recently received great news from the New York State Education Department regarding the boilers. The target timeline for installation is end of summer with an anticipated completion date of October 1.
 - Ms. Lavine, Mrs. Turner and the district nurses recently had a meet and greet from Dr. Smith, a local pediatrician from the LaFayette Family Health Center.
 - The Jr./Sr. High School had a bomb threat and Principal Chupaila supervised the process. We had protocol in place which was followed. We are going through a review and will "tweak" procedures.
 - Several people from the district attended the School Finance Forum at North Syracuse High School. Dr. Rick Timbs was the speaker.
 - Mrs. Blossey remarked that it was a great turnout for the Casio Fundraiser. The family is very thankful for the support of the community.
 - Ms. Lavine talked about her process for calling two-hour delays or snow days. She discusses it
 with Mr. Sawkins, Mr. Greeley, area superintendents and our administrators. She says every
 district is different, she uses 25 degrees below zero as a guideline.
 - There are 11 districts in New York State that provide services to Native American students. Ms. Lavine is presently attempting to schedule a day for all to meet along with officials of the NYSED. Ms. Ellsworth will host the meeting at her building.
 - Ms. Lavine said there is going to be a change in practice for registering students. We will be shifting registration from the buildings and going to a central registering at the District Office.
 - A webmaster training was held at the District Office on Thursday, February 12. There was good feedback from the attendees. On the same note, the school app is almost ready to unveil.
 - Ms. Lavine said in an effort to achieve consistency for all administrators regarding APPR, all
 administrators will observe one teacher together then compare feedback for a sense of
 uniformity for ranking.
