- 2015-2016 Final Draft Budget Presentation School Business Official Turner communicated to the Board the latest draft of the 2015-2016 Budget. She said there will be a 1.18% overall budget increase and a tax levy increase of .98%. The Budget Hearing is scheduled for May 7 at 5:30 p.m. at the Jr./Sr. High School.
- 3. Bus Bond Replacement Proposition: There is a \$408,000 bond coming due. Proposition II on the proposed budget vote for a total amount of \$305,000. This will allow the district to purchase 2-66 passenger school buses, 1-7 passenger van, 1-9 passenger suburban and 1 pickup service truck with a saving s of \$20,000 a year.
