Closing Remarks Public Comments Mr. LaRose reported he was surprised by SUNY Cortland with 'Thank You' gifts for taking three students to mentor, Kindergarten screening had begun and will continue through the 20th, Grimshaw Olympics are schedule for 6/13 (grades 1-3) and 6/14 (grades 4-6), we had great weather for Grandparents Day and all visitors got to go outside and walk on the track for PE (no Bingo due to the rain this year!). A fitness-gram is being put together for Grimshaw.

Mr. Kesler gave a Capital Project Update: We had minor issues with the Grimshaw windows, but all has been fixed and everything is almost complete; the boiler at the DO has been removed and 2 at the HS due to state law; Electricians are pulling wires in Grimshaw to feed new kitchen panels and cement was poured at Grimshaw and the HS Big Picture area; abatement is starting on Thursday night and working through to begin on Friday. It should be done by the weekend. Window insulation at the HS has begun, and working with Mr. Chupaila, contractors have gone through and will be working at night. Electricians are pulling data on the phone lines next week, and Big Picture's move is being scheduled to take over the area on 6/15. Mr. Kesler received notice from the state to proceed with the boiler work at ONS, the job kick off for this will be on the Tuesday after Memorial Day. He will be interviewing for summer help soon, and overall for the capital project we are on schedule with some things, a little behind in others, but building occupants and building schedules are taking priority.

Gretchen Gretsky reported on an issue that happened to her daughter on a late bus from the HS. She has had conversations with both Mr. Chupaila and Ms. Lavine regarding this incident, but wanted to make the board aware. Trustee D. Dodge asked what bus this was on and Vice President Johnson said that if something is presented as drugs, whether it is or it isn't actually, that is a problem and thanked her for informing the board.
