Regular Board Meeting September 11, 2014 Minutes - Amended

I. <u>Call to Order</u>

The Regular Meeting of the LaFayette Board of Education was held on Thursday, September 11, 2014, at the District Office Conference Room. President Dodge called the meeting to order at approximately 5:32 p.m. Present were: Trustees Keefe, Whitney, D. Dodge, Scofield, and Johnson. Also in attendance were Superintendent Lavine, School Business Official Turner and Board Clerk Munnell. IX. Superintendent's Report

Superintendent Lavine told the Board that the pipes at the Onondaga Nation School are being repaired and should be finished soon. Her October "Greensheet" news article is about visiting the buildings on the first day of school and asking students, "Does anyone know what a superintendent does?" From student, Caitlyn Campbell came the best job description she had ever heard: "You make sure that bad things don't happen" and with help from her classmates, "and that good things do happen."

There was a fireworks incident near the Jr./Sr. HS. Teacher Joe Fox heard a noise behind the buildings. He first called the office and then 911 which was the proper sequence that everyone should follow. All four schools and numerous employees handled the situation perfectly. Thank you to all involved.

The human enterovirus 68 (HEV68) is a respiratory virus that is causing some children to become ill. We have already started talking with students about the importance of good hygiene including covering one's mouth and nose when sneezing or coughing, and the role that handwashing plays in our health. We are paying especially close attention to our cleaning practices and the custodians are supplied with what they need and just reminding parents to practice good hygiene.

She was pleased to announce that she had the high honor of meeting with the Council of Chiefs today. She also attended her first Superintendent's meeting at BOCES. She told the Board that she has attended two faculty meetings so far with two to go. She asks the faculty: "What's on your mind? "What do you want me to know about?" and also shares her perspective on our priorities and goals.

Superintendent Lavine was given a tour of the Onondaga Nation by Onondaga Nation Representative Jacques. Superintendent Lavine updated the Board on school facilities via email from Jim Kesler: The pipes at ONS appear to be in good shape with no visible signs of breaks. Once the piping system is back to normal hanging, Mr. Kesler will call the boiler service company to conduct a full service and tune up. The water hammer at the high school has been repaired a couple of times. Once before the start of school and all seemed quiet until one day last week it was heard again. Another water pipe arrester was installed in the ceiling space in a science teacher's room. The noise has been greatly reduced, however, there is still movement with the pipes due to the amount of water pressure in the system. The plumber believes that additional hangers and supports are also needed. Mr. Kesler has requested a quote for the additional hangers & supports. Due to the amount of disturbance this would create, Mr. Kesler will schedule the work to be completed during the Holiday recess.

The smell at the High School is still evident but not as strong. The wall space has been cleaned and left open to air out as recommended. An enzyme digester (odor cleaner) will be used in the space to further help remove the smell. Don Warnow will be in the District on September 12 to inspect and offer further suggestions. The cracks in the sidewalk outside the doors have been filled and sealed to keep the rodents from entering.

Onondaga Nation Door security is in, however, not totally functioning. Mr. Kesler has scheduled a meeting for Wednesday, September 17 with Diane Ellsworth, and the contractor to discuss the needs to complete the installation. Mr. Kesler is seeking quotes for road salt and ice melter in preparation of winter weather. He is working with Rob Currier for door replacement at Onondaga Nation School. He will be scheduling his first District Health & Safety Meeting in near future.

The work should be completed either Monday or Tuesday.

Betty Lyons talked about the efficiency of the teacher and school nurse in the taking care of her child. He had a cold and with the recent outbreak of HEV68, the teacher immediately sent him to the nurse to make sure he was okay. Also she talked about sending possible edits regarding the code of conduct but they would not go through from her email, so she had someone else send them along for her.
