Regular Board Meeting March 13, 2014 Minutes

I. <u>Call to Order</u>

The Regular Meeting of the LaFayette Board of Education was held on Thursday, March 13, 2014, at the LaFayette Jr./Sr. High School-LGI. Ms. Cohen featured 7 findings along with recommendations for the District to work on. She finished her report stating the Big Picture does comply with Part 100 of the NYS Commissioner's Regulations.
