# 2024-2025 PROPOSED BUDGET

We are pleased to announce that our proposed 2024-2025 school district budget maximizes school district tax dollars for the benefit of

all our students. Here are a few examples of your past tax dollars at work:

- 97% graduation rate for June 2023 from the LaFayette Jr/Sr High and Big Picture (94% district-wide graduation rate for students in all programs).
- Several students in grades 8-12 received awards from the CNY Scholastic Arts Awards
- The High School Musical in March was a stellar performance showcasing the talent of our students
- Lancer fans had the chance to experience great performances by our student athletes and coaches
- Strong participation in career and technical education courses at OCM BOCES with over 19 juniors and seniors pursuing career and technical education training courses
- Personalized learning and internships for students enrolled at the Big Picture School
- Continued commitment to Onondaga Language instruction for High School students from the Onondaga Nation

As a district, our mission and vision statements and core beliefs have always guided our decision-making process. # STAR School Tax Exemption

You may be eligible for the following tax exemptions resulting in a reduction of your 2024/25 school tax bill. Contact your Town Assessor's office for more information. Estimates are based on a home assessed at \$100,000.

#### Basic Exemption: \$480 Est. Tax Savings

- Available for owner-occupied, primary residences;
- The income limit for the Basic STAR credit is \$500,000 (the income limit for the Basic STAR exemption is \$250,000):
- Based on the first \$30,000 of the full value of a home

#### Enhanced Senior Exemption: \$1,202 Est. Tax Savings

- Available on primary residence for 65+ years of age
- Household income of less than \$98,700 per year
- All Enhanced STAR recipients are required to participate in the Enhanced STAR Income Verification Program (IVP). In the first year that you apply for the Enhanced STAR exemption, your assessor will verify your eligibility based on the first \$84,000 of the full value of a home for the 2024-2025 school year.

#### How You Can Cast Your Vote

Early voting ballot or absentee ballot: Qualified voters\* of the District may obtain applications for an absentee ballot or an early voting ballot from the office of the Clerk of the District. Application requests to be mailed must be received no later than 4:00 p.m. on May 14, 2024. All other completed applications must be received by the Clerk of the District no later than 4:00 p.m. on May 20, 2024, and picked up in person. Completed absentee and early voting ballots must be received at the District Office by 5 p.m. on May 21. A voter who casts a ballot via early voting or absentee voting will not be eligible to vote in person on May 21, 2024.

In person voting: Qualified voters\* of the District may vote in person via voting machine or paper ballot on May 21, 2024 at 3122 Route 11 LaFayette, New York between the hours of 1:00 P.M. to 9:00 P.M prevailing time.

\*A qualified voter must be (1) a citizen of the United States, (2) at least 18 years of age; and (3) a resident of the school district for a period of at least 30 days preceding the meeting or election at which you seek to vote.

**Program Component** 

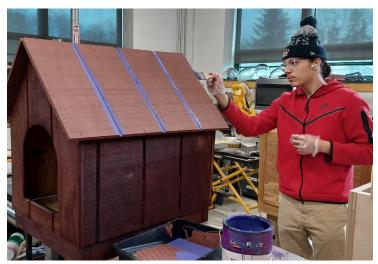
This budget category is the largest of the three budget components, representing 69.6% of the total components. It includes all expenditures directly related to the student educational program. Included are monies for all instructional personnel and programs including general education, occupational education, special education, technology, staff development and summer school. Also included are student services such as health, guidance, social worker, psychologist, library, co-curricular, athletics, transportation, census and the employee benefits for those programs.

Administrative Component

As defined by NYS Education Department, this budget category includes monies for the majority of the instruction support services in the District. It is comprised of a general support section, an instructional supervision section and a section for employee benefits for personnel in associated areas. This component represents 8.4% of the components. The categories marked with \* and \*\* represent 78% and 65%, respectively, of the amount needed to operate these services; the balance is charged to the State for administering and maintaining financial records for the Onondaga Nation School.

# 2024/2025 Propositions

#### **Proposition I - Budget**

Shall the proposed budget of \$24,195,663 for the LaFayette Central School District, as recommended by the Board of Education for the fiscal year beginning July 1, 2024, be adopted, and shall the Board of Education be authorized to levy the necessary taxes therefore.

#### Proposition II - Transportation

Shall the Board of Education of the LaFayette Central School District be authorized to purchase and finance three (3) 66-passenger diesel school buses, including necessary furnishings, fixtures, and equipment and all other costs incidental thereto, and expend a total sum not to exceed \$556,000, which is estimated to be the total maximum cost thereof, and said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District, in the principal amount not to exceed \$556,000, shall be issued.

#### Proposition III - Capital Reserve Construction

Shall the Board of Education be authorized to establish a capital reserve fund with a ten (10) year probable term pursuant to Section 3651 of the Education Law in an amount not to exceed \$5,000,000, inclusive of investment earnings, to be used for renovations and additions to all District facilities, including purchase of equipment, technology upgrades, classroom equipment and/or school infrastructure equipment, site development, athletic field and playground improvements, storm and sanitary sewer, driveways, and parking lots, such reserve fund to be funded from: (i) year-end budget surplus funds known as unassigned fund balance, as available, for the fiscal year ending June 30, 2024 and each fiscal year thereafter for the term of the reserve fund. (ii) transfers of excess monies from Board of Education designated reserves, (iii) amounts from budgetary appropriations from time to time, (iv) New York State Aid received and made available by the Board of Education from time to time, and (v) other legally available sources, all as permitted by law.

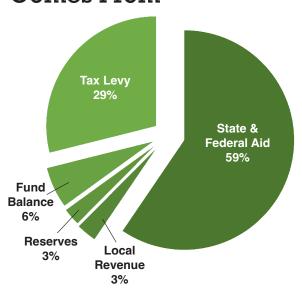
### **Proposition IV - Capital Reserve Vehicles**

Shall the Board of Education be authorized to establish a capital reserve fund with a ten (10) year probable term pursuant to Section 3651 of the Education Law in an amount not to exceed \$2,000,000, inclusive of investment earnings, to be used for the acquisition of vehicles, such reserve fund to be funded from (i) year-end budget surplus funds known as unassigned fund balance, as available, for the fiscal year ending June 30, 2024 and each fiscal year thereafter for the term of the reserve fund, (ii) transfers of excess monies from Board of Education designated reserves, (iii) amounts from budgetary appropriations from time to time, (iv) New York State Aid received and made available by the Board of Education from time to time, and (v) other legally available sources, all as permitted by law.

#### **Proposition V - Ex-Officio Student BOE Member**

Shall a high school senior student be designated to serve as an ex-officio member of the Board of Education, and thereby be entitled to sit with the Board members at all its public meetings, and participate therein, but without authority to vote on matters before the Board or to attend executive sessions.
