SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal

fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. • ARP-ESSER Application - Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such

notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

• ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the

plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. In conjunction with other available emergency relief resources, funds will be used to purchase air purification units for use in district classrooms and cafeterias. The air purification units developed by Healthway filter ultrafine particles as small as the coronavirus and have been deployed in hospital settings, K-12 classrooms, and college campuses. Additionally, the district has required the use of face masks by students and staff. The district is using federal funds to purchase additional adult and child-size masks for any staff member, student, or building occupant who does not have a face mask. The district is using federal money to purchase additional cleaning supplies, materials, and equipment to help prevent the spread of disease in our schools.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

The district will conduct baseline testing of all students relative to basic academic skills in the areas of ELA and Math using the STAR assessments. Baseline data will be used to inform instructional decisions and groupings. Students will also be monitored using a midyear and end of year assessment with STAR. The district also plans to use the Behavior Intervention and Monitoring Assessment System for students in grades 7-12 to identify students in need of additional behavioral support and/or mental health services.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

The district hosted students for summer school during the summer of 2021 and plans to host extended school year learning activities in future years to address learning loss. The district ran a four week program from July-August to target students in grades K-8 for additional support in core subject areas. Students in grades 9-12 had the chance to recover course credits through a regional summer program offered through OCM BOCES. Extended school year learning activities will continue in the summer of 2022 and 2023. The district is in the process of planning after school programs to extend and enrich learning beyond the school day. After school programs are tentatively planned for October-May from 2:45-5:00 PM on Tuesdays, Wednesdays, and Thursdays. After school programs will provide assistance with homework, classwork, and enrichment activities in the areas of science, technology, engineering, the arts, and mathematics.

The district will use remaining ARP ESSER funds to coordinate preparedness and response efforts with NYS, Onondaga County, the Onondaga Nation Council of Chiefs/Clanmothers/Faithkeepers, to respond to the pandemic and prevent the spread of disease. Funds will be used to train staff on sanitizing and minimizing the spread of disease, purchase of supplies to clean and sanitize school facilities. The district will also use available funds to address learning loss through extended school year programs/summer programs, and after school programs. The district will use evidence-based summer programs and after school programs to address student learning needs. The district is also expanding mental health support for students by purchasing a social/emotional learning curriculum, training staff, and hiring social workers to provide support to students and families. The district is partnering with Onondaga County Health Department, Coordinated Care Services, and Upstate Medical University to provide school based mental health counseling and coordinate access to community based resources to support students and families. LaFayette CSD serves students from the Onondaga Nation School and students from the Onondaga Nation. The Onondaga Nation community has been gravely impacted by COVID-19. 60.9% of the 64 COVID cases that were reported to school officials during the 2020-2021 school year were from our Native American students. It should be noted that there were only two cases out of the sixty-four COVID cases that were suspected due to school based contact. The majority of our cases resulted from spread within multi-generational families living in the same home. We will work with our families to encourage vaccination efforts, work with the Onondaga County Health Department to provide routine surveillance testing for COVID, and encourage practices to maintain healthy living. Onondaga County, the Onondaga Nation Health Clinic, and LaFayette CSD received a NYSDOH grant to encourage healthy eating and regular exercise. We look forward to working with staff members, students, and families to encourage lifestyle changes that improve overall community health such as healthy eating and regular exercise. The district is also maintaining a focus on improving academic outcomes for students. The district has implemented professional learning communities and has allocated time for staff members to collaborate and develop plans to address the academic needs of students. In the 2021-2022 school year, the district will implement a new English Language Arts curriculum and has identified a new core program to improve academic outcomes. The district is in the process of auditing, reviewing, and updating our math curriculum to make sure that student academic needs are being addressed. The district has hired additional personnel to assist with meeting the academic needs of our students and to support teachers with professional development to better address the learning needs of our students.

The district has informed parents of the safety precautions in place to address the health and safety needs of our students which include: universal mask wearing during periods of high community transmission of COVID, physical distancing of at least three feet between students, encouraging hand washing and respiratory hygiene, cleaning and maintaining healthy facilities, and working with the county and state health departments to complete any required contact tracing when positive cases occur.

The district was able to provide in person instruction for the entirety of the 2019-2020 at three schools: Grimshaw Elementary, LaFayette Jr/Sr High School, and LaFayette Big Picture School. The Onondaga Nation School remained fully remote for the 2019-2020 school year at the request of the Onondaga Nation. The district has worked closely with the Onondaga Nation to formulate a plan to return students for in person instruction at the Onondaga Nation School for summer school and for the start of the 2021-2022 school year. The district provided electronic learning devices, hotspots, and delivered meals to our remote learners on the Onondaga Nation throughout the pandemic. The district remains ready to switch to remote learning if needed based on ever changing conditions as a result of COVID-19. The district does not plan to use ESSER funds for the purposes of school construction.

The district is grateful to have the availability of additional funding to meet the learning needs of our students. LaFayette CSD provided summer learning programs at Grimshaw Elementary, the Onondaga Nation School, and LaFayette Jr/Sr High School during the summer of 2021. The district also partnered with OCM BOCES Regional Summer School to provide our students in grades 9-12 with the opportunity to recover course credits during the summer of 2021. The district plans to continue with summer learning programs and use available federal funds to support these extended learning opportunities.

The district is in the process of developing after school programs to offer students the chance to obtain additional academic support after school hours. The district is partnering with the Onondaga Nation, Cornell University, and Syracuse University to provide additional tutoring for students from the Onondaga Nation.

The district will use federal funds to address the academic, social, emotional and mental health needs of all of our students; especially our students from low-income families, students of color, English language learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.
